Annette Mosman appointed CEO of APG

Annette Mosman has been appointed Chairman of the Executive Board of APG Group (APG) with effect from 1 March 2021. She succeeds Gerard van Olphen, who joined APG as CEO in 2016 and who will resign effective April 1. Mosman has been a member of the APG Executive Board as CFRO since February 2018. Annette Mosman's appointment has been approved by the shareholders and regulator. Annette Mosman is the first female CEO of APG.

Annette Mosman has been a member of the APG Executive Board as CFRO since February 2018 and is responsible for finance, risk management, IT and data. In addition, she actively contributed to the development of APG's new strategy.

Mosman has extensive leadership experience in the financial sector. Since 2011 she has been a member of the board of directors of insurance company Generali Nederland; first as CFRO, since 2015 as CEO. From 2006 to 2009, she was responsible, as associate partner at KPMG Advisory, for CFO advisory services to major banks and insurance companies. Between 1997 and 2006 she advised companies in the financial sector from KPMG Consulting (later Atos Consulting) on setting up an efficient and effective finance function. From 1992 to 1997, Mosman audited large Dutch companies in various sectors as an auditor at KPMG Accountants. Mosman is a member of the board and treasurer of NOC*NSF, member of the supervisory board of the Jeroen Bosch Hospital, member of the supervisory board of KWF Kankerbestrijding, and member of the supervisory board of AFC Ajax NV She is married and has three children.
